Our services are offered in 18 counties and are designed to provide transportation to and from rural areas that previously had little or no transit services.



Transportation can include rides to and from medical facilities, shopping, personal needs, nutrition centers, and much more.

Clients that are eligible for Medicaid and have been approved for transportation are provided transportation at no cost to and from, Medicaid providers only.

This does not cover transit services for personal needs. Reservations must be made 2 business days prior to the appointment for transportation services.

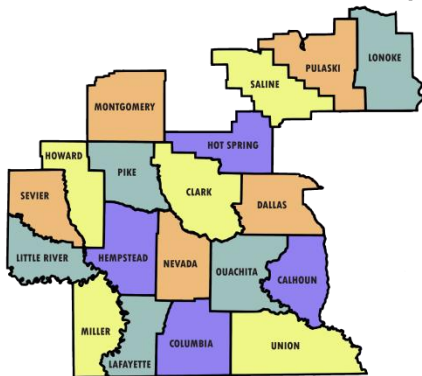
